## **Topics Discussed:**

- Mr. Gavlick discussed possible changes to Ridership meeting schedule & location. The members

- Mr. Gavlick discussed and explained new Pittston Circulator Route.
- Mr. Gavlick gave an update on the statues of the LCTA audits that have been and are being conducted.
- Mr. Gavlick mentioned that LCTA is asking the City of WB for permission to create several bus stops on Washington St., in order to alleviate congestion at the Intermodal Center.
- Mr. Gavlick informed the committee that LCTA will be installing new video systems on Shared Ride Vans by Mid-November. In addition; LCTA is looking for grant money to upgrade to HD cameras on all fixed route buses.

- Ms. Vandermark was asked to briefly discuss upcoming Marketing Programs: Veterans Day,
   Poetry in Transit, Holiday Bus & Stuff the Bus Food Drive.

- Ms. Vandermark informed the committee of new programs and tours available for "First Time Riders" and school classes, etc.
- A member from PTAC asked if LCTA could produce bus signs advertising PTAC meetings, in order to increase attendance. LCTA officials Stated: It would be looked in to, but should not be a problem.

- A member of the public asked about Shared Ride Drivers not allowing shopping carts on the vans. LCTA Officials stated: We need specific dates and times to examine incidents. Safety procedures for carts was also discussed.
